INFRASTRUCTURE POLLUTION POLICY FORM FOR INFRASTRUCTURE PROJECTS

An exclusive, competitive solution designed to protect all stakeholders from the catastrophic environmental risk pertaining to hard infrastructure projects (roads / bridges / airports / rail / ports) including Public-Private Partnerships.

CAPACITY: Up to \$25,000,000 each Pollution Condition / \$25,000,000 aggregate. Higher limits available (if required).

POLICY TERM: Up To 10 Years (PLL Coverage Part); Up to 13 years (Policy + Completed Operations (CPL Coverage Part)).

EXCLUSIVITY: Policy Form may be accessed through the RT Environmental and Construction Professional Practice (ECP).

KEY COVERAGES: Provides full sudden / accidental and gradual pollution coverage, including clean-up (no retroactive date), third party bodily injury, property damage (including natural resource damages), emergency response costs and defense.

Coverage A: Contracting Services Pollution Liability Coverage - Occurrence

Coverage B: Covered Location Pollution Liability Coverage - Claims-Made

Coverage C: Non-Owned Location Pollution Liability Coverage

Coverage D: Crisis and Reputation Management Expenses Coverage

1. Name / Address of First Named Insured (Entity Signing Contract)
2. Project Scope of Work including Construction Values and Term
3. Project Location (address / longitude & latitude - Point A to Point B)
4. Available Environmental Due Diligence (i.e., Phase I Environmental Site Assessments (ESA) / Phase II ESA; Remedial Action Work Plan; Geotechnical Reports or Soil Management Plans), if applicable
